This arbitration will be conducted by a single neutral arbitrator and administered by the American Arbitration Association (or a similar arbitration service selected by the parties) in a location mutually agreed upon by the parties.

The arbitrator's award shall be final, and judgment may be entered upon in any court that holds jurisdiction. Suppose any legal or equitable action, proceeding, or arbitration arises from or concerns these terms and conditions. In that case, the prevailing party shall be entitled to recover its costs and reasonable attorney's fees.

The parties agree:

- To arbitrate all disputes and claims regarding these terms and conditions.
- To arbitrate all disputes and claims arising as a result of these terms and conditions (whether directly or indirectly, including tort claims resulting from these terms and conditions).
- That the Federal Arbitration Act governs the interpretation and enforcement of this provision.

The Arbitrator shall determine the entire dispute, including the scope and enforceability of this arbitration provision. This arbitration provision shall survive the termination of these terms and conditions.

#### **I. Termination/Access Restriction**

Twelve21 Global reserves the right, in its sole discretion, to terminate your access to the site and the related services—or any portion thereof—at any time without notice. To the maximum
